## Terms and Conditions

As BASSCARE is a government-funded aged care service provider:

- Clients registered with My Aged Care and eligible for the Commonwealth Home Support Program (CHSP) are entitled to subsidised prices.
- Clients who choose not to register with My Aged Care will not be eligible for subsidised prices and will instead be charged the standard fee.
- Clients receiving funding from other government programs, such as Support at Home or the National Disability Insurance Scheme (NDIS), will be charged the standard fee.
- For Support at Home clients, the standard fee for Meal Services consists of a 30% client contribution and a 70% package contribution.
